#### CALL TO ORDER AND INVOCATION

Mayor Brundige called the January 13, 2003, meeting of the City of Martin Board of Mayor and Aldermen to order. Alderman Harrison gave the invocation.

#### PLEDGE OF ALLEGIANCE

Mayor Brundige led the group in the Pledge of Allegiance to the Flag.

#### PRESENTATION OF AWARDS:

#### **Volunteer Distributors:**

Public Safety Director J. D. Sanders explained, on New Year's Eve the city embarked on an innovative program here in Martin. It was designed to do what safety is all about and that is to prevent instances of drunk driving. It is easy to go out and get arrests for drunk driving but that does not get the folks that are endangering all of us off the road and our intent on New Year's Eve was to do just that. We wanted to get as many drunk drivers as we could off the road. We know how important that is, for example, in 1999 in the State of Tennessee, there were 1169 fatal automobile crashes of that number 429 of them or 37% were alcohol related. In the year 2000, there were 5702 youth between the ages of 16 and 20 killed in traffic accidents, even though teenagers make up only 7% of the licensed drivers 15 % of all fatal crashes are from teenagers, 41% of fatal

crashes involving teenagers occur at night between 9:00 PM and 6:00 AM. Efforts made by America's

With these statistics in mind, the Martin Public Safety Department partnered with Volunteer Distributers on New Year's Eve to supply the community with a bus that would transport folks from one party to another. Volunteer Distributers called in December and asked to sponsor this bus at a cost of \$600.00. On December 31<sup>st</sup> we transported approximately 175 citizens of Martin that elected to ride the bus as opposed to being on the road drinking at any level.

Mr. Randy Gregory, Manager of Volunteer Distributers, was present. Director Sanders thanked Mr. Gregory and Volunteer Distributers for this partnership on New Year's Eve, their kind donation and for the offer to do future partnerships.

Mayor Brundige presented Mr. Gregory with a plaque of appreciation. And thanked he and Volunteer Distributers for the money donated to partner with the city providing the New Year's Eve bus.

Mr. Gregory stated, "On behalf of Volunteer Distributers, I certainly appreciate the opportunity to partner up with Martin Police Department for this New Year's Eve. One of the programs, and we have several programs on our consumer awareness and this is one of the great programs that we have. One thing I would like to mention to the board and everyone here, just so you will know, Anheuser Bush has what you call "Team Talk", it is a publication they put out to over 800 wholesalers. This story I shared with "Team Talk" and hopefully this will make the publication and go out to the 800 wholesalers and share these ideas and hopefully some of these other police departments and jurisdictions around the country will be able to do programs like this..... This was a great partnership and we appreciate the opportunity to partner up with you and look forward to doing other things with you in the future. Thank you."

#### **Director's Award - Dwayne Williams:**

Director Sanders stated, the Board is already aware of this second presentation. We normally like to make this presentation at our annual Christmas Party. We take time to recognize those employees in the department of Public Safety who have gone above and beyond the call of duty but the recipient could not be present. This person is here tonight and I want to tell a little bit about him. His name is Dwayne Williams. Dwayne come to us from Knoxville, Tn and he just dropped in out of nowhere one day and said he wanted to intern. He is a student at the University of Tennessee at Martin. He chose Martin to come to school and he wants to be an EMT. We want to present the Director's Award for 2002 to Dwayne. In addition to him serving as an intern, he served as a volunteer reserve firefighter and an EMT. He has become so common place at the fire station that they thought he was a live-in resident. He was very helpful and always ready to do anything that was asked of him. And, just to show you how much the firefighters admire him, they bestowed on him the best nick name that could ever come to him "Buster".

Director Sanders presented Mr. Williams the Director's Award, naming him as an Honorary Fire Chief for the Martin Fire Department.

Mr. Williams said his thanks to Chief Sanders and the guys at the fire department and expressed appreciation

for this opportunity.

Mayor Brundige presented for the Second and Final Reading and Public Hearing, Ordinance O2002-16: An Ordinance to amend Sections 2-207, 2-209(1)b, 2-210(b), and 2-213 of the Alcoholic Beverage Control Ordinance of the City of Martin, Tennessee, O96-12. This is the public hearing and a recommendation from the Alcohol Beverage Control Board. Published in the Weakley County Press December 24, 2002.

Mr. Tidwell read Ordinance O2002-16, a copy follows:

#### ORDINANCE O2002-16

AN ORDINANCE TO AMEND SECTIONS 2-207, 2-209 (1)b, 2-210 (b), and 2-213 OF THE ALCOHOL BEVERAGE CONTROL ORDINANCE OF THE CITY OF MARTIN, TENNESSEE, 096-12.

BE IT ORDAINED BY THE MAYOR AND BOARD OF ALDERMEN OF THE CITY OF MARTIN TENNESSEE, THAT:

SECTION 1. Section 2-207 (d)1, of the Alcohol Beverage Control Ordinance of the City of Martin is amended by adding the following to begin at the end of the existing section which shall read as follows:

An Employee advisory policy will be attached to the application.

SECTION 2. Section 2-209 (1)b replaces the number (30) with the number (75).

SECTION 3. Section 2-210 (b), deletes language following playground, and replaces it with:

Class B Permits—On Premises Permit Holders: Seven Hundred Fifty Feet from a direct line

measured between the property line upon which the beer will be stored or sold to the nearest point on the property line of the hospital, school, day care center, church, public park, or playground. The establishment of the location of the property lines will be the responsibility of the applicant.

SECTION 4. Section 2-213 Legal hours of Sale. Deletes this entire section and replaces it with the following:

Legal Hours of Sale:

The legal hours of sale for all permit holders will be between the hours of 6:00 A.M. and 3:00 A.M. Monday through Saturday. No such beverage will be sold between 3:00 A.M. and Noon on Sunday. No alcoholic beverages shall be consumed or opened for consumption, on or about any premises licensed hereunder, in either bottle, glass, or any other container, after 3:15 A.M. each day.

SECTION 5. This ordinance will take effect immediately upon its passage on the second and final reading, the public welfare requiring it.

SECTION 6. BE IT THEREFORE ORDAINED, that this Ordinance shall become effective immediately upon passage after the second and final reading, THE PUBLIC WELFARE REQUIRING IT,

INTRODUCTION AND FIRST READING OF RESOLUTION R2003-01: RESOLUTION ADOPTING A PLAN OF SERVICE FOR THE ANNEXATION OF PAYNE SUBDIVISION WEST SIDE OF HARRISON ROAD AND NORTH SIDE OF STELLA RUTH ROAD.

Mayor Brundige introduced for the first reading Resolution R2003-01: Resolution adopting a Plan of Service for the Annexation of Payne Subdivision west side of Harrison Road and north of Stella Ruth Road. This is a recommendation from the Planning Commission and the owner of the property.

Mr. Tidwell read Resolution R2003-01. A copy follows:

#### RESOLUTION R2003-01

A RESOLUTION ADOPTING A PLAN OF SERVICES FOR AN AREA TO BE ANNEXED INTO THE CITY OF MARTIN, TENNESSEE: AN AREA REFERRED TO AS PAYNE SUBDIVISION ON THE WEST SIDE OF HARRISON ROAD NORTH OF STELLA RUTH ROAD.

WHEREAS, *Tennessee Code Annotated* 6-51-102 as amended requires that a plan of services be adopted by the governing body of a city prior to annexing an area; and,

WHEREAS, the Martin Municipal-Regional Planning Commission has recommended the following Plan of Services for the annexation of an area referred to as Payne Subdivision on the west side of Harrison Road north of Stella Ruth Road.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF MAYOR AND ALDERMEN OF THE CITY OF MARTIN. TENNESSEE:

for the proposed annexation area the following Plan of Services:

#### A. Police

- (1) Patrolling, radio responses to calls, and other routine police services, using present personnel and equipment, will be provided on the effective date of annexation.
- (2) No additional personnel or equipment will be added during the first year after the effective date of annexation, but as the area develops, additional personnel and equipment will be expanded as needed.
- (3) Traffic signals, traffic signs, street markings, and other traffic control devices will be installed as the need therefore is established by appropriate study and traffic standards.

#### B. Fire

- (1) Fire protection by the present personnel and the equipment of the fire fighting force, within the limitations of available water and distances from fire stations, will be provided on the effective date of annexation.
- (2) No additional personnel or equipment will be added during the first year after effective date of annexation, but with the growth and development of the area additional personnel and equipment will be expanded as needed.

#### C. Water

- (1) Water for domestic, commercial and industrial use will be provided at the rates presently charged by the City of Martin, on the effective date of annexation, and thereafter from new lines as extended in accordance with current policies of the city.
- (2) Water for fire protection is currently available, with additional fire hydrants to be added as development occurs.

#### D. <u>Sewer</u>

The necessary sewer lines will be installed on undeveloped property according

Harrison Road adjacent to this property with the necessary sewer lines for the subject subdivision property to be installed by the owner at his expense..

#### E. Refuse Collection

The same regular refuse collection services now provided within the City will be extended to the annexed areas within one month after the effective date of annexation.

#### F. Streets

- (1) Emergency maintenance of streets (repair of hazardous chuckholes, measures necessary for traffic flow, etc.) will begin upon acceptance of the street(s) by the City of Martin but no earlier than the effective date of annexation.
- (2) Routine maintenance, on the same basis as in the present city, will begin in the annexed areas upon acceptance of the street(s) by the City of Martin but no earlier than the date when funds from the state gasoline tax based on the annexed population are received.
- (3) Reconstruction and resurfacing of streets, installation of storm drainage facilities, construction of curbs and gutters, and other such major improvements, as need therefore is determined by the governing body, will be accomplished under current policies of the city.

#### G. <u>Inspection Services</u>

Any inspection services now provided by the city will begin in the annexed areas on the effective date of annexation.

#### H. <u>Planning and Zoning</u>

The planning and zoning jurisdiction of the city will extend to the annexed areas on the effective date of annexation. City planning will thereafter encompass the annexed areas. According to an ordinance proposed by the Martin Municipal-Regional Planning Commission, the area will be zoned R-1 (Low-Density Residential).

#### I. Street Lighting

residential areas within approximately 60 months after the effective date of annexation, under the standards currently prevailing in the city.

#### J. Recreation

Residents of the annexed areas may use all existing recreational facilities, parks, etc. on the effective date of annexation. The same standards and policies now used in the present city will be followed in expanding the recreational program and facilities in the enlarged City.

#### K. Miscellaneous

Street name signs where needed will be installed as new streets are opened in the annexed area.

SECTION 2. THAT THIS RESOLUTION shall take effect 30 days from and after the date of final reading of the annexation ordinance, THE WELFARE OF THE CITY REQUIRING IT.
