Mayor Brundige called the November 10, 2003, meeting of the City of Martin Board of Mayor and Aldermen to order. Alderman Belote gave the invocation.

Alderman Nanney made the motion to approve the minutes of the October 14, 2003, meeting as written, seconded by Alderman Johnson.

MARTIN BEAUTIFUL COMMITTEE: PAINTING OF GAZEBO

Mayor Brundige introduced Mr. Marvin Downing, Chairman of the Martin Beautiful Committee.

Chairman Downing addressed the board, we understand that the city is going to paint the city hall building. With this in mind, the Martin Beautiful Committee respectfully request the inclusion of painting the ceiling and sides of the gazebo in this undertaking. The gazebo is made of treated wood which has aged for approximately three months making it ready for paint. The floors will be sealed as well as the concrete around the gazebo.

# INTRODUCTION AND READING OF RESOLUTION R2003-20: RESOLUTION AUTHORIZING BUDGET AMENDMENT TO THE CITY OF MARTIN, TENNESSEE GENERAL FUND FOR THE FISCAL YEAR ENDING JUNE 30, 2004

Mayor Brundige introduced and presented Resolution R2003-20: Resolution authorizing Budget Amendments to the City of Martin, Tennessee General Fund for the Fiscal Year ending June 30, 2004. These amendments are insurance monies paid for storm damages that we need to place in the budget.

Mr. Tidwell read Resolution R2003-20. A copy follows:

#### RESOLUTION R2003-20

RESOLUTION AUTHORIZING BUDGET AMENDMENT TO THE CITY OF MARTIN, TENNESSEE GENERAL FUND FOR THE FISCAL YEAR ENDING JUNE 30, 2004

WHEREAS, the City of Martin was hit by a storm that did damage to several buildings owned by the city; and

INTERAGENCY AGREEMENT BETWEEN CITY OF MARTIN AND MARTIN HOUSING AUTHORITY

Mayor Brundige introduced a request to approve an Interagency Agreement between City of Martin and Martin Housing Authority. The city will purchase the materials and do the work with the Martin Housing Authority paying for the project, estimated cost \$41,000.00. A copy follows:

### INTERAGENCY AGREEMENT BETWEEN MARTIN HOUSING AUTHORITY AND CITY OF MARTIN

This Interagency Agreement is entered into by and between the Martin Housing Authority (hereinafter referred to as MHA) and the City of Martin ((hereinafter referred to as the City).

WHEREAS, the purpose of this agreement is to enable MHA and the City to coordinate services that will benefit residents of public housing; and

WHEREAS, federal and state officials encourage the coordination of services among and between local government entities; and

WHEREAS, MHA us actively involved in strategies to improve services while limiting expenses; and

WHEREAS, the City has the capacity to perform necessary site work that will improve the quality of life for MHA residents in a cost-effective manner; and

WHEREAS, the cost of provision of such services has been estimated to be around \$41,000; and

WHEREAS, Capital Funds are available to pay for the necessary improvements as outlined in a blue print and specifications.

NOW, THEREFORE, let it be resolved that the parties agree to cooperate in the completion of site improvements to MHA as outlined in the cost estimate and work specifications.

Alderman Johnson made the motion to approve an Interagency Agreement between City of Martin and Martin Housing Authority, seconded by Alderman Nanney.

CAP CITY'S CONTRIBUTION ON HEALTH INSURANCE, WHERE WE

#### ARE TODAY. Recommendation from the Finance Committee.

Mayor Brundige presented a request to cap City's contribution on health insurance, where we are today. This is a recommendation from the Finance Committee.

Alderman Merryman made a motion to cap the amount of the city's contribution on health insurance, where we are today, seconded by

Mayor Brundige asked for a second to the motion, there was no second made. Motion dies for lack of a second.

Alderman Johnson made the motion to put off considering this cap until the end of this budget year or December 31, 2004.

Mayor Brundige stated, we can't wait that long.

Mr. Tidwell stated, Mr. Johnson, if you are going to do that, you will need to cap it as June 30, 2004, so we would know exactly what to do in next year's budget. The insurance rates become effective on January 01 of each year so it would have to be capped as of June 30 of each year to allow us to finalize the budget.

Alderman Merryman made the motion to cap the amount of city's contribution on health insurance as of June 30, 2004, seconded by Alderman Boyd.

Alderman Belote asked, "Why is it imperative that we need to cap tonight?"

Mr. Tidwell stated, "Alderman Belote, the insurance, the reason it has to be done tonight is that the employees have got till November 15<sup>th</sup> to make up their mind where they want to change or do whatever they want to do. After November 15<sup>th</sup> they don't have another change insurance until October 15<sup>th</sup> of next year. So, that is the reason it has to be imperative to tonight, so they will know exactly what they have to do or where they are going to be and what they are going to do. So, if they are going to make any changes it can get back into us toward the end of this week so we can get it in by the 15<sup>th</sup> of November."

Alderman Belote asked, "So, the reason for the cap is for the curtsey of the employees?"

Mr. Tidwell stated, "To let them know exactly what they ... how to make plans and find out exactly what they want to do. We have had meetings, we had meetings, Monday, I am sorry, Friday, with all of the employees, went through the new plan and I told them and how it is and everything else, and I told them then, that the decision would be made tonight, so they could make a decision either Wednesday or Thursday of this week so that we can have time to get it all, it there are any changes to be made, we will have time to key punch it in and to get it in by the 15<sup>th</sup>. Which, I think the 15<sup>th</sup>

is Saturday. We will have to know something so they will know something, is exactly what they want to do and how they want to do it."

Alderman Johnson stated, "Well, my motion would be to end discussion on, any discussion on the cap until after this budget year, ending June 30, 2004. Phillip motion is to, if it passes tonight is to cap it as of June 30, 2004, without any discussion, just do it."

Alderman Merryman stated, "If you don't do it eventually we are going to have to end having employee insurance. We won't be able to continue to pay."

Alderman Johnson stated, "But, we could at least at it in the next budget year."

Alderman Merryman asked, "For how long?"

Alderman Johnson stated, "We would have time to cap it before another raise."

Alderman Merryman stated, "The employees would not have the opportunity to make their decision."

Alderman Belote stated, "I am still having difficulty understanding this."

Alderman Johnson stated, "I am too."

Mr. Tidwell stated, "Alright, January 01 of this year we get, we get, a rate increase which I informed the employees last Friday there is a ten percent increase in PPO and a twelve percent increase in POS. That will last for one calender year. Now, wether you cap it as of June 30 or wether you wait until the end point start of the budget, you are still are still going to be capping it at the same figure. Right now you are paying 80% of the employee family plan. Now, as I said, if you cap it now or as of June 30<sup>th</sup> or after that period of time, you still going to be using the same cap. So, it is really immaterial wether you do what Alderman Merryman said or basically, it is going to be the same figure. Basically, what you are doing right now is you are just saying is you will wait until January 01 when the figures come out with the rate increases....sometimes during that period of the year, and Alderman Merryman's motion was on June 30<sup>th</sup>, cap it at the figure the city is going to be as of January 01. It will the same figure all year long, so, you are right, you are right and he is right. But, this way it will be able, instead of setting there in July and August working on the budget, maybe we can get the budget done before June 30<sup>th</sup>. You will know what figure you are going to be able put in the that budget and work the figures into the budget itself. And you will know what figure that is and you will know what figure that is."

Alderman Johnson asked, "They will not incur a rate increase until a year from this coming January?"

Mr. Tidwell answered, "Right now, if it stands as it is right now with no caps everybody including the city will experience a rate increase come January 01. And, the primary reason we are having to do it again, not only for what they area going to know, for us in the payroll department, we have to start deducting in December for January's payment. We deduct one month ahead of what we are doing. Everybody will increase, the city and the employees will experience a rate increase come January 01 based on the figures that have come down from the state."

Alderman Johnson asked, "But our percentage that the city pays will stay the same?"

Mr. Tidwell stated, "It will be eighty percent, yes sir. We are not changing that. We did that in July 1st of this year."

Mayor Brundige asked, "Any other discussion, if not roll call vote."

Alderwoman Boyd asked, "May I change mine. This is June 30<sup>th</sup>."

Alderman Merryman spoke, "It does not matter if it is January 1<sup>st</sup> or June 30<sup>th</sup>, we could cap it next November 1<sup>st</sup> and it is still going to be the same price. This way it lets the employees know and it allows the Finance Committee to work on the budget with an exact number in there. So we know a little bit what we are doing, than we have in the past."

Alderman Belote stated, "Another issue is we don't have to cap it at all."

Alderman Merryman stated, "That is correct. We could continue to pay the rate increases and eventually start laying people off."

Alderman Belote stated, "I haven't heard that from the Finance Committee. I haven't heard that recommendation to lay people off, if we were not to do this. I haven't seen that come by yet."

Alderman Merryman asked, "Did you not hear that at the Informal Meeting last Tuesday night?"

Alderman Belote answered, "I heard that, but I haven't seen facts and figures yet that indicate that we are going to lay people off if we cap this thing. I'm not necessarily against the cap if we've gone through this budget and that's the last we have to do or the only thing we can pull out of it to make a budget. But, we haven't done that work yet."

Mayor Brundige asked, "Alderwoman how do you want to vote?"

Alderwoman Boyd asked, "It doesn't matter if we cap or not cap, it is still going to remain the same?"

Alderman Merryman responded, "No, if we do not cap the city will absorb rate increases from now until such time as we do cap."

Alderman Johnson spoke, "Since Phillip's first motion failed for lack of a second, and then, I am kinda like David, why do we have to cap it tonight? Why can't we say we are going to leave it like it is till June 30<sup>th</sup> or until sometime during the 04-05 budget process and leave it open for further discussion and then we, if we deem it necessary to cap it, we can do it whenever. Everybody is saying it doesn't matter, anytime during the next calendar year."

Alderman Merryman stated, "With one exception, they will not know what they are going to be paying if we don't do something tonight."

Alderman Johnson spoke, "Aren't they going to know, next year what.."

Mr. Tidwell spoke, ".....Mayor, I have said, you'll are really in the vote session and yo really need to back off and withdraw your motion, withdraw your second and let's start all over discussion, all over, because right now you are in the vote session and you are not suppose be discussing it."

Mayor Brundige asked, "Alderwoman Boyd, how do you vote.?"

Mr. Tidwell said, "Or they can withdraw their motion and second and start all over."

Alderman Merryman spoke, "it is going to come down to the same vote. I am not going to withdraw the motion."

Alderwoman Boyd voted: No.

#### RESIGNATION: DIRECTOR OF PUBLIC SAFETY J. D. SANDERS

Director of Public Safety J. D. Sanders read his resignation:

"To: Mayor Randy Brundige and the City Board:

With my eyes toward the future and very mindful of the many wonderful people in Martin, I tender my resignation as Director of Public Safety for the City of Martin. I have agreed to accept the position of Chief of Police for the City of Columbus, Mississippi, effective December 01, 2003.

It has been an honor to serve with the many fine women an men of the Martin Police and Fire Departments. It has also been an honor and pleasure to serve the people of Martin and the dedicated Martin City Boards during my watch. One of the things I am particularly proud of is that I will be leaving both departments in great shape, in spite of sever budget restraints the past few years. The City of Martin should share in the pride of having the higest caliber of professionals to continue providing the kind of public safety services they deserve and have come to expect.

I will be available for anything Mayor Brundige may need during the transition period and will gladly return to Martin when needed. My last official working day will be November 30, 2003, unless Mayor Brundige decides to alter the time.

Thank you all for making the efforts you do to serve the citizens of Martin. I know firsthand the dedication and determination to do what is right that you all have demonstrated. There is a very bright future for Martin and much of it is because of that dedication coupled with a vision for the years ahead.

I have always subscribed to the Boy Scouts' pledge to always leave a campsite in better shape than they found it. I hope in some small way, I have contributed to the efforts to improve the quality of life for everyone in Martin, Tennessee, my home town.

They all have not only been good advisors but have been good friends over the years. I will never forget the kindness of Patsy Duncan and Dr. Susan Johnson during Christmas season fourteen years ago. I greatly appreciate the working relationship I have enjoyed with every board since 1995. I have been very privileged to serve under two outstanding mayors. I truly believe he has Martin headed in the right direction and with the help of the other six board members some really good things are on the horizon for Martin. The Dresden Enterprise is another friend to all departments in the county, especially us and I appreciate our working relationship them too. We have also enjoyed a good working relationship with other public safety organizations in this area. Sheriff Mike Wilson and his staff have always provided the support we have needed anytime we've asked. I appreciate Circuit Judge Bill Acree, General Session Judge Tommy Moore, Juvenile Judge James Bradberry and District Attorney Tommy Thomas and their respective staffs. I owe a great deal of thanks to the command staffs at the police and fire departments. All of them have been and are very capable professionals who work daily to continue to improve the delivery services for the citizens of this town. They have provided guidance and direction to me and the department and we have worked as a team and made team decisions. To all the members of Public Safety, you are the greatest. I sincerely mean it when I say, you are the best there is. No one could ever hope to have a better team of dedicated, loyal, hard working professionals as there are right here in Martin. In Public Safety, size really doesn't matter no matter wether you live in New York, Nashville, or Martin everyone deserves to feel safe secure and protected. And, the people in Martin are getting a bargain for the quality of the work force they have here. And thanks to the citizens of Martin for demanding and funding the best department anywhere. There are some really good people here in Martin. I hope those out there that take for granted the many wonderful benefits of living in Martin will look around and see how lucky they are to be here. And finally, to my best friend and wife Becky. Behind every successful person is a supportive spouse. Becky has endured a lot when I have had to be away so many times and when the phone rings at two o'clock in the morning, she wakes up too. Everyone should be so blessed to have that kind of partnership. Becky is one of the main reasons, I have made this difficult decision. Becky and I are excited about beginning our new adventure and we will surely miss the many special people that have been our friends and have made my 23 years in Martin so wonderful. As, I have said before, no matter where we end up, Martin will always be our home town and besides that it is connected too because Highway 45 runs right down our front door. Thanks."

#### **ORDINANCE 02003-22**

## AN ORDINANCE DELETING CHAPTER 8 OF TITLE 1 OF THE MARTIN MUNICIPAL CODE PROVIDING FOR THE POSITION OF DIRECTOR OF PUBLIC SAFETY FOR THE CITY OF MARTIN

WHEREAS, the Charter for the City of Martin provides that the Board of Mayor and Aldermen may establish, merge, or consolidate offices, positions of employment and departments, and may transfer or change the functions and duties of offices, positions of employment and departments; and

WHEREAS, the Board of Mayor and Aldermen has determined the administration of the Police and Fire Department of the City of Martin would be more effectively and efficiently managed by the elimination of the position of Director of Public Safety with the appointment of both a Police Chief and Fire Chief.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND ALDERMEN OF THE CITY OF MARTIN, TENNESSEE, THAT;

Section 1. That Chapter 8 of Title 1 of the Martin Municipal Code is hereby repealed in it entirety.

Section 2. If any provision of this ordinance or the application thereof to any person or

circumstances is held invalid, such invalidity shall not effect other provisions or applications of this ordinance which can be given effect without the invalid provision or application, and to that end the provisions of this ordinance are to be severable.

Section 3. BE IT FURTHER ordained that this Ordinance shall become effective immediately upon its passage after second and final reading THE PUBLIC WELFARE REQUIRING IT.
