MARTIN MEMORIAL GARDENS

Alderman Harrison stated the Cemetery Committee was approached by the Board of Trustees from the Martin Memorial Gardens asking the city to take over the ownership of the Martin Memorial Gardens and I wish to present a recommendation from the Cemetery Committee. The recommendation is to assume ownership of Martin Memorial Gardens which will include the management, the assets, and the liabilities. The assets include 1434 lots available for sale, the

Memorial Gardens is located adjacent to city owned Parham Cemetery, cemetery fund has \$25,000.00, a track of land 150' X 300' is located to the rear of cemetery available for lots, and the city will own every cemetery inside the city limits. The liabilities include the foundation around the Prayer Book is in need of repair (I think the city can do this repair), the statue of the angel needs repair, one road acts as entrance and exit into the cemetery, road needs to be resurfaced, and the mowing/maintenance of the area, estimated mowing costs \$1400/\$1500 annually. The ownership papers have been reviewed and a title search done by the city's legal staff.

Alderman Harrison made the motion, the City of Martin assume ownership of the Martin Memorial Gardens which includes management, assets and liabilities, seconded by Alderman Belote.

LANDFILL FILL DOZER LEASE: POWER EQUIPMENT COMPANY, 2002 KOMATSU D61EX-12, SERIAL#B1840, WITH 1500 HOURS AND 5000 HOUR POWER TRAIN WARRANTY. PRICE \$133,925.00. SIXTY (60) MONTH

LEASE @ \$2,458.86 PER MONTH WITH ONE PAYMENT IN ADVANCE (FULL PAY OUT GOVERNMENT LEASE)

Mayor Brundige presented a recommendation from the Public Works Committee to lease/purchase a landfill dozer from Power Equipment Company. It is a 2002 Komatsu D61EX-12, Serial #B1840, with 1500 hours and a 5000 hour Power Train Warranty. Price is \$133,925.00. Sixty (60) month lease at \$2,458.86 per month with one payment in advance. This will be a full pay-out government lease. Our dozer is down at the landfill and we will have to replace the dozer if we plan to keep it open. This was bid out through Public Works.

Alderman Nanney made the motion to to lease/purchase a landfill dozer, 2002 Komatsu D61EX-12, Serial #B1840, with 1500 hours and a 5000 hour Power Train Warranty from Power Equipment Company. Price is \$133,925.00 with a sixty (60) month lease at \$2,458.86 per month, one payment in advance with a full pay-out government lease, seconded by Alderman Harrison.

Bids were taken by Public Works for the sale of the old landfill dozer that does not run. The engine is completely out. The highest bidder was Mr. Collins.

FIRE AERIAL TRUCK: COST \$135,000.00; WITH TRADE-INS THREE (3) TRUCKS VALUE \$3,000.00 AND A GENERATOR AND TELESCOPING LIGHT STICK, VALUE \$7,000.00 - TOTAL PRICE AFTER TRADE-INS, \$98,000.00.

Mayor Brundige presented a request from Chief True to purchase a Fire Aerial Truck for the City of Martin Fire Department. Cost \$135,000.00; with trade-ins, three trucks valued at \$3,000.00 and a generator and telescoping light stick valued at \$7,000.00, reducing the cost to \$98,000.00.

Chief True spoke, I took Captain Bob Dudley, who inspects fire trucks and works with Pearce apparatus on a regular basis, and Russel Schwan, who is familiar with the inter working of ladder fire trucks, to Deep South Trucks in Mississippi. We spent two days going over this truck. We know where it came from, Charlotte, NC. We called Charlotte and got the history of the vehicle before we went down and we also found out what was paid wholesale for the vehicle. Upon going through the vehicle for two days we had a page and a half punch-list. Deep South Trucks has agreed to the specs listed on the punch-list. Basically, what you are going to get is a completely refurbished aerial, 105 foot stick, which is a ladder without a platform at the top that will service the city seven to ten year very well, the motor and transmission have been gone through, the pump and aerial will be certificated with current certification, it will be fully repainted, new wheels and tires, it will have new interior work done, it will be lettered Martin Fire Department, and within that deal we have also gained enough five inch vinyl hoses to supply not only that aerial but engine eight(the five inch hose is our supply hose especially in a rural setting), and 1000 feet of one, three-quarter inch hose (used for interior fire fighting), three month warranty on the vehicle and there is a local service person.

Mayor Brundige stated, this has already gone before the Finance Committee and it will be three months before we have to purchase the truck. If this is approved tonight, then it will return to the Finance Committee to secure funding.

Alderman Johnson made the motion to purchase a Fire Aerial Truck. Cost \$135,000.00 with trade-ins, three trucks valued at \$3,000.00 and a generator and telescoping light stick valued at \$7,000.00 reducing the cost to \$98,000.00, seconded by Alderman Belote.

Mayor Brundige introduced and presented for the first reading Ordinance O2004-11: An Ordinance to amend the Municipal Zoning Ordinance and Map for Martin, Tennessee, by rezoning six (6) tracks located at the southeast intersection of University and Elm Streets from R-1 (Low Density Residential) to B-3 (Central Business), then read the ordinance. A copy follows:

ORDINANCE 02004-11

AN ORDINANCE TO AMEND THE MUNICIPAL ZONING ORDINANCE AND MAP FOR MARTIN, TENNESSEE BY REZONING SIX TRACTS LOCATED AT THE SOUTHEAST INTERSECTION OF UNIVERSITY AND ELM STREETS FROM R-1 (LOW DENSITY RESIDENTIAL) TO B-3 (CENTRAL BUSINESS).

- WHEREAS, pursuant to Tennessee Code Annotated, Section 13-7-201 through 13-7-211, the City of Martin has adopted a Municipal Zoning Ordinance; and
- WHEREAS, in accordance with Tennessee Code Annotated, Sections 13-7-203 and 13-7-204, the Martin Municipal-Regional Planning Commission has recommended the following amendment to the Municipal Zoning Ordinance and Municipal Zoning Map relative to the rezoning of territory; and
- WHEREAS, the Martin Board of Mayor and Aldermen has deemed such a rezoning of this territory to be necessary for the welfare of the residents and property owners thereof this City as a whole; and
- WHEREAS, the Martin Board of Mayor and Aldermen has held a public hearing pursuant to

Tennessee Code Annotated, Section 13-7-203 for the purpose of receiving public comment.

NOW, THEREFORE, BE IT ORDAINED BY THE MARTIN BOARD OF MAYOR AND ALDERMEN:

Section 1. That the Municipal Zoning Map and Zoning Ordinance for Martin, Tennessee be amended by rezoning the following six tracts from R-1 (Low Density Residential) to B-3 (Central Business):

Weakley County Tax Map 73M, Group E, Parcels 00100, 00200, 00300, 00400, 01600 and 01700

Section 2. BE IT FURTHER ORDAINED that this Ordinance shall become effective immediately upon its passage after second and final reading, THE PUBLIC WELFARE REQUIRING IT.

LAWSUIT: MS. KATHY HATLER

Mayor Brundige passed out the following memo:

SUBJECT: MS. KATHY HATLER LAWSUIT

The City of Martin settled a long pending lawsuit last week filed by former City of Martin Police Officer Kathy Hatler. The Fair Labor Standards suit filed by Hatler after her termination by then Police Chief J. D. Sanders in January 2003 claimed wrongful termination and asked for damages in excess of \$230,000.00. Following the advice of the Tennessee Risk Management Pool Attorney's (the City of Martin's insurer), the City and Ms. Hatler agreed to settle the lawsuit through mediation.

Our advisors made this recommendation by weighing the additional costs of proceeding with a jury trial and appeals against the settlement cost which amounted to \$100,000.00 (66.7% if which will be paid by the City of Martin and 33.3% by the Tennessee Municipal League).

Settlement agreements secured during mediation do not constitute an admission by the employer of any violation, but are designed to avoid lengthy costly litigation that in many cases may exceed settlement costs.

The City will pay it's portion of the settlement costs (approximately \$66, 667.00) through a loan from the city's own gas department to be paid back interest free over the next five years in \$13,333.40 installments.

Mayor Brundige explained, I need a motion to pay the approximately \$66,667.00 to Ms Kathy Hatler by borrowing this amount from the city's gas fund interest free over the next five year a with payment of \$13,333.40 installments.

Alderman Johnson made the motion to settle the law suite filed by Ms Kathy Hatler in the amount of \$66, 667.00 by borrowing this amount from the city's gas fund interest free over the next five years, with payment of \$13,333.40 installments, seconded by Alderman Nanney.

APPRAISAL OF PROPERTY AT CORNER OF FREDERICK STREET AND BROADWAY

Alderman Edwards explained, the city owns the property located at the corner of Frederick Street and Broadway Street. This is where the old Martin Manufacturing plant was located. It appears that there may be some interest in purchasing this property, therefore, I propose the city get an appraisal and dispose of the property, if the city has no use for it. An appraisal would cost Approximately \$300.00.

Mayor Brundige stated, if we choose to sell this property it would have to be sold by sealed bids or at auction.

Director Vowell stated, there is a sewer line, not encased, that crosses the property about midway of the lot. It ran under the old Martin Manufacturing Plant. A developer could develop on either side.

Mayor Brundige asked what the pleasure of the board was.

Alderman Edwards made the motion to have an appraisal done on the property located at the corner of Frederick Street and Broadway Street, seconded by Alderman Johnson.

ANNOUNCEMENT OF CITY OF MARTIN FIRE DEPARTMENT GRANT FROM ALL STATE INSURANCE

Fire Chief True announced the All State Insurance Foundation has graciously given the City of Martin a grant to purchase smoke detectors in the amount of \$3,750.00. Ms. Liz Helton, local All State Insurance Agent, was instrumental in helping us secure the grant. We are very appreciative. We will start the process in a week or two. Some of the local miniseries will help us locate the needs in our community. The fire department will go out and install these.

We have also received fifteen hand held radios that are narrow band compliance from our FEMA Grant 2003 Enter-Operable Communication.

HOME LAND SECURITY GRANT

Police Chief Moore stated, the police department participated in part of the same grant, this department received approximately \$15,000.00 earmarked for wireless enter-operable communication system to network the entire city system.

STREET LIGHTS DOWNTOWN

Alderman Nanney asked if the street lights downtown had been fixed.

Director Vowell stated, sometimes when I come through town the lights are off and the next time they are on. I think it is a photo-cell.

Alderman Nanney asked the police department to watch the lights and report back to Public Works.

Chief Moore said they would be glad to do that.
