ORDINANCE O2005-05

AN ORDINANCE FOR THE CITY OF MARTIN TO ADOPT THE TENNESSEE DEPARTMENT OF TRANSPORTATION TITLE VI COMPLIANCE AND IMPLEMENTATION PLAN.

- WHEREAS, the City of Martin desires to comply with federal and state statutes; and
- WHEREAS, the Board of Mayor and Aldermen, pursuant to *Tennessee Code Annotated*, Section 6-2-201, desires to ensure non-discrimination in its practices and day to day business in accordance with Title VI of the Civil Rights Act of 1964; and
- WHEREAS, the City of Martin has found the Tennessee Department of Transportation Title VI Compliance and Implementation Plan to be a valuable aid in pursuit of such compliance.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF MARTIN BOARD OF MAYOR AND ALDERMEN that:

- Section 1. the Tennessee Department of Transportation Title VI Compliance and Implementation Plan is hereby adopted in its entirety; and
- Section 2. the City Recorder is hereby designated as the City of Martin Title VI Officer and Coordinator.

INTRODUCTION AND FIRST READING OF ORDINANCE O2005-06: AN ORDINANCE TO AMEND THE MUNICIPAL ZONING ORDINANCE AND MAP FOR MARTIN, BY REZONING PROPERTY ALONG OAKLAND STREET

Mayor Brundige introduced and presented for consideration, the first reading of Ordinance O2005-06: An ordinance to amend the Municipal Zoning Ordinance and Map for Martin, by rezoning property along Oakland Street.

City Recorder Mathis read Ordinance O2005-06. A copy follows:

ORDINANCE O2005-06

AN ORDINANCE TO AMEND THE MUNICIPAL ZONING ORDINANCE AND MAP FOR MARTIN, TENNESSEE, BY REZONING PROPERTY ALONG OAKLAND STREET.

- WHEREAS, pursuant to *Tennessee Code Annotated*, Section 13-7-201 through 13-7-211, the City of Martin has adopted a Municipal Zoning Ordinance; and
- WHEREAS, in accordance with *Tennessee Code Annotated* Sections 13-7-203 and 13-7-204, the Martin Municipal-Regional Planning Commission has recommended the following amendment to the Municipal Zoning Ordinance and Municipal Zoning Map relative to the rezoning of territory; and
- WHEREAS, the Martin Mayor and Board of Aldermen has deemed such a rezoning of this territory from R-2 (Medium-Density Residential) to R-3 (High Density Residential) to be necessary for the welfare of the residents and property owners thereof this City as a whole; and
- WHEREAS, the Martin Board of Mayor and Aldermen has held a public hearing pursuant to *Tennessee Code Annotated* Section 13-7-203 for the purpose of receiving public comment.

NOW, THEREFORE, BE IT ORDAINED BY THE MARTIN MAYOR AND BOARD OF ALDERMEN:

Section 1. That the Municipal Zoning Map and Zoning Ordinance for Martin Tennessee be amended by rezoning from R-2 (Medium-Density Residential) to R-3 (High Density Residential) property located along Oakland Street, and further described as:

Weakley County Tax Map 73-M, Group A, Parcels 00401, 00501 and 00500 and Weakley County Tax Map 73M, Group B, Parcels 02800, 02900 and 03000.

Section 2. BE IT FURTHER ORDAINED that this Ordinance shall become effective immediately upon its passage, after second and final reading, THE PUBLIC WELFARE REQUIRING IT.

APPROVE EASEMENT FOR COX-McCARVER/MTD ALONG RAILROAD SPUR

Mayor Brundige presented the easement description of 37 feet along the railroad spur needed for Cox-McCarver and MTD Products improvements. This space will be used mainly for parking.

The description follows: Beginning at the southwest corner of Lot 2 of the Martin Industrial Park (Weakley County Plat Book 3, Page 186), also the southeast corner of a tract owned by Kelly and Swaim (Weakley County Deed Book 323, Page 444); thence, in a southwesterly direction in line with the west line of said Lot 2 a distance of 37 feet; thence, in a southeasterly direction parallel with the south line of said Lot 2, also parallel to the tracks of the City of Martin Railroad, a distance of 408 feet; thence, in a northeasterly direction a distance of 37 feet to a point in the south line of said Lot 2; thence, in a northwesterly direction along the south line of said Lot 2 a distance of 408 feet to the point of beginning with said easement lying within the property and right-of-way of the City of Martin Railroad.

Alderman Nanney made the motion to approve a 37-foot easement as described above for Cox McCarver/MTD along the Industrial Park access railroad spur, seconded by Alderman Tuck.

BID OPENING FOR THE REHABILITATION OF THE RAILROAD SPUR TO THE INDUSTRIAL PARK

Mayor Brundige explained on April 02, 2005, at 2:00 pm the bids were opened for the construction rehabilitation of the railroad spur that serves as an industrial access to the Industrial Park. Three bids were received, South Central Tennessee Railroad - \$407,100.00, Balfour Beatty Rail, Inc. - \$465,166.67, and Railworks Track Service - \$566,999.40. The low bid of \$407,100.00 was from South Central Tennessee Railroad. Do I have a motion to accept this bid contingence upon approval from Tennessee Department of Economic and Community Development?
