## CALL TO ORDER AND INVOCATION

Mayor Brundige called the September 12, 2005 meeting of the City of Martin Board of Mayor to order and gave the invocation.

## PRESENTATION OF CERTIFICATE CHIEF DAVID MOORE

Chief David Moore presented a Certificate of Recognition and Thanks to Mr. Harry Don Moore. This certificate is to recognize and thank Mr. Moore for outstanding service and dedication to the community and interest in the public. Mr. Moore has shown himself to be a good neighbor. Our department received a burglary call from a house on Woodland Street and upon going to investigate and doing a neighbor canvas, as is typical, we came across Mr. Moore. Mr. Moore provided information that led to the solution of the burglary. A portion of Investigator Randal Walker's report follows: "On May 19, 2005, I spoke with the victim Paul Long and ask him about forced entry to his residence and etc...at this time I went to Woodland Street and spoke to resident Moore who lives across the street from the Long's residence. Mr. Moore stated that he observed one white male in a black t-shirt go up to the door, act like he put a key in the door, then entered the residence. The other white male wearing a camouflage shirt was looking up and down the street. Shortly the second white male in the camouflage shirt went into the residence and one-half to two minutes later both subjects exited the residence and

went behind the residence just north of that address. Moore also observed the two white males setting on a swing two houses north of that address. Moore stated that when the two males left the swing they went to the front of a residence at another address and a white female came to the door. At this time Moore used his 35-millimeter camera and photographed the two white male subjects. Moore printed me a picture from his computer and identified the two subjects (names were not given because they were minors)." To make a long story short not only did he observe what he thought to be suspicious activity in his neighborhood because he knows his neighborhood but he took the time to get detailed information and two photos. Also, through this investigation the department found out the two teens were not only responsibility for this crime but another one as well. We just want to say thank you from the Martin Police Department and the City of Martin for making our jobs easy.

## **DEPARTMENT HEADS REPORTS:**

## PUBLIC WORKSDIRECTOR CHARLES VOWELL

Director Vowell explained the city's new Street Sweeper has arrived. We used it to clean up before, during, and after the Soybean Festival. The sweeper is doing a good job. We are now setting up a program to clean every street in the city.

## PARKS AND RECREATION DIRECTOR DENNIS SUITER

Director Suiter passed out his monthly reports.

Director Suiter reported the Soybean Festival activity at the Martin Recreational Complex this Saturday included MTD Car Show, Soccer Jamboree, the Tractor Pull, Kiwanis 5-K Run and 1-Mile Fun Walk. I feel like it went extremely well for the first year. This was the first time for us to host the MTD Car Show and have this much Festival activity going on at the MRC. I am proud to say the biggest problem was traffic and that is a very good thing. My department has evaluated this problem and we are making plans to solve it.

## MAYOR THANKS EMPLOYEES

Mayor Brundige stated I wish to thank all of the employees and sponsors for their participation in the Soybean Festival. It was a great success and the entire praise goes to those who helped. We had great entertainment and had huge crowds downtown every night.

## FIRE DEPARTMENT CHIEF ORAN TRUE

Chief True explained the department took photos during the tractor pull and car show and aerial photos Saturday night at 7:00 pm and again at 9:00 pm just to see the difference in the crowd from the initial act and the headline act. You will be amazed at the crowd. You could not put another person in. It was crowded. The Festival was very successful. We treated twenty patients in two nights, fifteen on Friday night and five on Saturday. Fortunately none were serious with the exception of Alderman Belote, who was transported to Vanderbilt in Nashville.

Fireman Brandon Fletcher, who is a member of the Military Police Unit out of Ripley, Tennessee, was deployed August 31<sup>st</sup> for an indefinite period of time. Lt. Russell Schwan and Lt. David Blake have been deployed to the FEMA Headquarters for Disasters located in Atlanta. They received training yesterday and will receive deployment orders soon.

## POLICE DEPARTMENT CHIEF DAVID MOORE

Chief David Moore reported that Officer Nick Glenn, who was injured in the line of duty, is back at work and feeling good. Also Officer Larry Baker has been off with some heart problems that will be treated with medication. We hope to have Larry back soon. Last Saturday night was Officer Terry Guthrie last night. He is going to Afghanistan for a year. He promises me he will be back to work when his year is up.

I want to read a memo that will be posted on our bulletin board to thank my department, "Dated September 12, 2005. Once again I have the opportunity of thanking each and every one of you for a job well done during the planning, organization, and tireless performance of duty during the Soybean Festival. I cannot tell you how important your teamwork and dedication to community and to the entire City of Martin is. I cannot ask for more from anyone of you including office staff, codes enforcement, communications, officers and command staff alike. You have out performed my highest expectations. I am pleased to say that due to your diligence, high visibility, and problem solving approach we had very few incidents in relation to the number of people in your care during the entire week. Sense of pride and team is apparent. Thank you for representing this department with the professionalism we have all come to expect from the officers and staff of the Martin Police Department." Sincerely, David Moore, Chief of Police. I fee very strongly about my department and just wanted to share that publicly. Thank you.

I have also lost one officer for at least twenty-one days, Officer John Cross who is a member of the Air Wing unit out of Nashville's Tennessee National Guard, has been activated for duty in Nashville to allow the Nashville unit to go to the coast and help with storm victims. And to go along with this we are also working with several counties to form a strike team to help. The strike team project is being coordinated by Jackson Police Department. The Martin department will send one car with two men.

#### ORDINANCE O2005-11

#### AN ORDINANCE TO AMEND THE MUNICIPAL ZONING ORDINANCE FOR MARTIN, TENNESSEE, CHANGING THE MINIMUM DEVELOPMENT SIZE IN R-1A DISTRICTS FROM TEN ACRES TO FIVE ACRES

WHEREAS, pursuant to *Tennessee Code Annotated*, Section 13-7-201 through 14-7-211, the City of Martin has adopted a Municipal Zoning Ordinance; and

WHEREAS, in accordance with *Tennessee Code Annotated*, Section 13-7-201 through 14-7-204, the Martin Municipal-Regional Planning Commission has recommended the following amendment to Article V. <u>PROVISIONS GOVERNING RESIDENTIAL DISTRICTS</u>, Section A.1 <u>R-1A (HIGH DENSITY SINGLE FAMILY RESIDENTIAL DISTRICTS)</u> Subsection 4 <u>Bulk Regulations</u> of the Municipal Zoning Ordinance;

WHEREAS, the Martin Mayor and Board of Aldermen has deemed such to be necessary for the welfare of the residents and property owners thereof this City as a whole; and

WHEREAS, the Martin Board of Mayor and Aldermen has held a public hearing pursuant to *Tennessee Code Annotated*, Section 13-7-203 for the purpose of receiving public comment.

NOW, THEREFORE, BE IT ORDAINED BY THE MARTIN BOARD OF MAYOR AND ALDERMEN:

SECTION 1. That the text of the Zoning Ordinance of Martin, Tennessee be amended by amending Article V, Section A.1, Subsection 4 a by changing the regulation from:

The minimum development size for the R-1A Zoning District shall be ten (10) acres to:

The minimum development size for the R-1A zoning District shall be five (5) acres.

SECTION 2. BE IT FURTHER ORDAINED that this Ordinance shall become effective immediately upon its passage, after the second and final reading, THE PUBLIC WELFARE REQUIRING IT.

#### AN ORDINANCE TO AMEND THE MUNICIPAL ZONING ORDINANCE FOR THE CITY OF MARTIN, TENNESSEE CHANGING THE OFF STREET PARKING REQUIREMENTS AND THE MINIMUM PARKING STALL DIMENSIONS.

WHEREAS, pursuant to *Tennessee Code Annotated*, Section 13-7-201 through 13-7-211, the City of Martin has adopted a Municipal Zoning Ordinance; and

WHEREAS, in accordance with *Tennessee Code Annotated* Sections 13-7-203 and 13-7-204, the Martin Municipal-Regional Planning Commission has recommended the following amendments;

WHEREAS, the Martin Mayor and Board of Aldermen has deemed such to be necessary for the welfare of the residents and property owners thereof this City as a whole; and

WHEREAS, the Martin Board of Mayor and Aldermen has held a public hearing pursuant to *Tennessee Code Annotated* Section 13-7-203 for the purpose of receiving public comment.

NOW, THEREFORE, BE IT ORDAINED BY THE MARTIN MAYOR AND BOARD OF ALDERMEN:

SECTION 1. That the text of the Zoning Ordinance of Martin, Tennessee be amended by deleting the following from Article III, Section H, Subsection 3,

Each parking space shall be equal to an area of 200 ft2. The width shall not be less than 10 feet and the length shall not be less than 20 feet.

... and replacing it with the following,

Each parking space shall have a minimum width of 9 feet and a minimum length of 18 feet.

SECTION 2. That the text of the Zoning Ordinance of Martin, Tennessee be amended by deleting Article III, Section H, Subsection 8 and replacing it with the following table:

Office	1 space per 300 gross square feet
Retail	1 space per 200 gross square feet
Over 10,000 sq. ft.	1 space per 300 gross square feet
Restaurant	1 space per 100 gross square feet
Health Club	1 space per 100 gross square feet
Warehouse	1 space per 1,000 gross square feet
Assembly	1 space per 300 gross square feet
Medical Office	1 space per 200 gross square feet
Schools	1 space per 3.5 seats in assembly rooms plus 1 space per faculty member
Day Care / Child Care	1 space per care room (Minimum of 5 spaces) with adequate stacking area
Hotels / Motels / Dormitories	1 space per guest room plus 1 space per each 500 square feet of common area
Industry	1 space per 1,000 square feet
Over 100,000 sq. ft.	1 space per 5,000 square feet

SECTION 3. BE IT FURTHER ORDAINED that this Ordinance shall become effective immediately upon its passage, after second and final reading, THE PUBLIC WELFARE REQUIRING IT.

# WEAKLEY COUNTY CHAMBER OF COMMERCE-TENNESSEE SCHOLARS

Ms. Audrey Roberts, representing the Weakley County Chamber of Commerce and Weakley County Education Edge Board of which she is a member, explained the Tennessee Scholars Program.

Ms. Roberts spoke the theme is "Education Makes Us What We Are". The Tennessee Scholars Program is a business led, rewards and incentives campaign that encourages students to take a more rigorous and challenging course of study in high school. This will encourage Weakley County Students to do their very best. A Tennessee Scholar must complete 4 English courses, 4 mathematics courses (Algebra I and II, Geometry, and one higher level math), 3 science courses (Biology and two other lab sciences), 3 history (government and economics, etc), 1 business/computer course, 1 wellness course, 1 fine arts course, 2 foreign language courses in the same language, 2 technical courses in the same technical track, 20 hours of community service, overall "C" average in all Tennessee Scholars Courses, 95% attendance, no out-of-school suspensions, and pass all Gateway exams. We are asking that you as a board support and encourage participation in this program. We will all be winners and hope to have 60% participation has chosen to include this in their school's program. A pamphlet describing this program is attached.

- WHEREAS, the President of the United States issued Homeland Security Directive/ HPSD-5 requiring adoption of the National Incident Management System (NIMS) for providing Federal preparedness assistance through grants, contracts, or other activities; and
- WHEREAS, the Board of Mayor and Aldermen has determined that adoption of NIMS is in the City's best interest and benefits the general welfare of all its citizens.

#### NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF MAYOR AND

ALDERMEN OF THE CITY OF MARTIN that the National Incident Management System (NIMS), shall be utilized by all city departments as standardized procedures for managing personnel, communications, facilities, and resources in domestic incident management.
