APPROVAL OF MINUTES JANUARY 09, 2006

Alderman Nanney made the motion to approve the minutes of the January 9th meeting as written, seconded by Alderwoman Boyd.

DEPARTMENT HEADS REPORTS:

POLICE DEPARTMENT CHIEF DAVID MOORE

Chief Moore explained Chief True and I will be participating in a Safe School exercise and will be giving input into school safety plans in Weakley County. Also, Officer Nick Glenn has been assigned as the School Resource Officer at Martin Middle School and the hiring process has begun for filling two vacancies in the patrol division of our department.

FIRE DEPARTMENT

CHIEF ORAN TRUE

Chief True explained at the Safe School exercise this next week the Weakley County Fire Chiefs will be presenting twenty new weather radios and backup batteries to all of the schools. We purchased these out of agency funds and firemen will be delivering them Friday. This means each school will have a weather radio and be able to receive weather information without delay.

We also hosted at UTM a National Grant Writing Seminar for the Fire Act. The seminar was very successful as we had a lot of community involvement and a lot of representation from area fire departments. Mr. Ray Crouch was there from MTAS. We received a lot of excellent information and made several very good contacts. In the past, the department has applied for Fire Act Grants funds but has not been successful. Mr. Couch and the grant writer could not understand why we were not funded as we met all of the priority funding requirements established by FEMA. They consented to review last year's application and make suggestions for improvement. We will try again this year to procure grant funds in the neighborhood of \$140,000 to supply our department with air packs and turnout gear for each fireman.

PUBLIC WORKS

DIRECTOR BILLY GENE WAGSTER

Director Wagster explained he would answer any questions concerning the monthly reports.

Mayor Brundige complimented the department on an excellent job done during the weekend snow.

C. E. WELDON PUBLIC LIBRARY DIRECTOR ROBERTA PEACOCK

Director Peacock explained the Library would be offering a new service beginning February 27th. This program is called The Reads, a regional e-books and auto books download system, which can be done from your personal computer by downloading free software and using your library card. The patron will be able to download full test books to their computer or download an audio book to an MP3 player, computer or burn them to a disk.

A hundred and twenty people attended countdown to Kindergarten this past Saturday despite the horrible weather.

INTRODUCTION, PRESENTATION AND FIRST READING OF ORDINANCE 02006-01: AN ORDINANCE TO AMEND THE MUNICIPAL ZONING ORDINANCE AND MAP FOR MARTIN, TENNESSEE, BY REZONING PROPERTY AT 188 HIGHWAY 431 (WEST OF UNIVERSITY STREET).

Mayor Brundige introduced and presented for the first reading Ordinance O2005-01: An ordinance to amend the Municipal Zoning Ordinance and Map for Martin, Tennessee, by rezoning property at 188 Highway 431 (west of University Street). This is a recommendation from the Planning Commission.

Recorder Mathis read Ordinance O2006-01. A copy follows:

ORDINANCE 02006-01

AN ORDINANCE TO AMEND THE MUNICIPAL ZONING ORDINANCE AND MAP FOR MARTIN, TENNESSEE, BY REZONING PROPERTY AT 188 HIGHWAY 431 (WEST OF UNIVERSITY STREET).

WHEREAS, pursuant to *Tennessee Code Annotated*, Section 13-7-201 through 13-7-211, the City of Martin has adopted a Municipal Zoning Ordinance; and

WHEREAS, in accordance with *Tennessee Code Annotated* Sections 13-7-203 and 13-7-204, the Martin Municipal-Regional Planning Commission has recommended the following amendment to the Municipal Zoning Ordinance and Municipal Zoning Map relative to the rezoning of territory; and

WHEREAS, the Martin Mayor and Board of Aldermen has deemed such a rezoning of this territory from R-1 (Low Density Residential) to R-3 (High Density Residential) to be necessary for the welfare of the residents and property owners thereof this City as a whole; and WHEREAS, the Martin Board of Mayor and Aldermen has held a public hearing pursuant to *Tennessee Code Annotated* Section 13-7-203 for the purpose of receiving public comment.

NOW, THEREFORE, BE IT ORDAINED BY THE MARTIN MAYOR AND BOARD OF ALDERMEN:

Section 1. That the Municipal Zoning Map and Zoning Ordinance for Martin Tennessee be amended by rezoning from R-1 (Low Density Residential) to R-3 (High Density Residential) property located at 188 Highway 431 (west of University Street), and further described as:

Weakley County Tax Map 73, Parcel 01701.

Section 2. BE IT FURTHER ORDAINED that this Ordinance shall become effective immediately upon its passage, after second and final reading, THE PUBLIC WELFARE REQUIRING IT.

Mayor Brundige introduced Mr. Arby Smith, owner and representative of Rich Smith Development, which is proposing to build The Villas of Martin, a senior living community.

Mr. Smith explained he was the managing member of Rich Smith Development. In several states my company has developed multi-family and senior independent living units. The proposed Martin unit located at 188 Highway 431 will be called the Villas of Martin and will be a gated community for senior adults fifty years and older. Some of the amenities will be a gated community only accessed by remotes, one level with one or two bedrooms units, garages with remotes, club house, swimming pool, hot tub area, fitness center with state of the art fitness equipment, community room, card room, laundry facilities, beauty salon, movie theater that will seat 26 to 35 people, all units energy efficient, heat pumps, R16 to R38 insulation, micro wave, vent-a-hoods, refrigerators with ice makers, washer and dryer hookups, and library with internet connection. We are proposing 54 units on a concrete slab that will be built using approximately 75% brick and 25% siding with architectural roof shingles. This will be a residential neighborhood with affordable rental units. We are the developers, construction company, managers, and owners and are here for the long term and are really excited about Martin. Our manager or maintenance person or both will live on site. We have a slight problem as we have a timeline of March 20th to get the rezoning completed.

Mr. Smith further explained we are going through the Tennessee Housing Authority for tax credit but we are not subsidized. We have constructed a unit of this sort in Jackson, Tennessee if you all would like to visit. When we start our units, we try to open the clubhouse first or the units and clubhouse at the same time. In our independent living units we do a background and credit check on the occupant. We will work with the police and fire departments to insure safety and security in the community. We want to be good neighbors because we will be landowners, taxpayers and because this is a \$6/8,000,000 project.

Several of the aldermen stated they had received calls expressing concerns for the proposed development relating to the nature, had no prior knowledge of the development and could not answer questions. After receiving information on the proposed development and having their questions answered the aldermen asked for additional time to allow them to share the information with the community before considering the proposed ordinance.

Mayor Brundige explained the utilities are available across the road from the address.

A brochure describing the proposed community is attached to minutes.

Board agreed to recess the meeting until February 27th at noon to consider this ordinance.

Mayor Brundige explained we have discussed for several weeks hiring a City of Martin Development Director. The office has been vacant for several months.
