INTRODUCTION, PRESENTATION, AND CONSIDERATION OF THE FIRST READING OF ORDINANCE O2008-02: AN ORDINANCE TO AMEND THE MUNICIPAL ZONING ORDINANCE AND MAP FOR MARTIN, TENNESSEE, BY REZONING A TRACT OF LAND LOCATED AT 235 UNIVERSITY STREET FROM R-2 (MEDIUM DENSITY RESIDENTIAL) TO R-4 (RESIDENTIAL-PROFESSIONAL)

Mayor Brundige introduced and presented for consideration Ordinance O2008-02: An ordinance to amend the Municipal Zoning Ordinance and Map for Martin, Tennessee, by rezoning a tract of land located at 235 University Street from R-2 (Medium Density Residential) to R-4 (Residential-Professional). This is a recommendation from the Planning Commission. Ordinance O2008-02 was tabled at the May 12th meeting. I am now requesting a motion to remove the ordinance from the table.

AN ORDINANCE TO AMEND THE MUNICIPAL ZONING ORDINANCE AND MAP FOR MARTIN, TENNESSEE, BY REZONING A TRACT OF LAND LOCATED AT 235 UNIVERSITY STREET FROM R-2 (MEDIUM DENSITY RESIDENTIAL) TO R-4 (RESIDENTIAL-PROFESSIONAL).

WHEREAS, pursuant to *Tennessee Code Annotated*, Section 13-7-201 through 13-7-211, the City of Martin has adopted a Municipal Zoning Ordinance; and

WHEREAS, in accordance with *Tennessee Code Annotated* Sections 13-7-203 and 13-7-204, the Martin Municipal-Regional Planning Commission has recommended the following amendment to the Municipal Zoning Ordinance and Municipal Zoning Map relative to the rezoning of territory; and

WHEREAS, the Martin Mayor and Board of Aldermen has deemed such a rezoning of this territory from R-2 (Medium Density Residential) to R-4 (Residential-Professional) to be necessary for the welfare of the residents and property owners thereof this City as a whole; and

WHEREAS, the Martin Board of Mayor and Aldermen has held a public hearing pursuant to *Tennessee Code Annotated* Section 13-7-203 for the purpose of receiving public comment.

NOW, THEREFORE, BE IT ORDAINED BY THE MARTIN MAYOR AND BOARD OF ALDERMEN:

Section 1. That the Municipal Zoning Map and Zoning Ordinance for Martin Tennessee be amended by rezoning from R-2 (Medium Density Residential) to R-4 (Residential-Professional) the following tract of land located at 235 University Street and further described as:

Weakley County Tax Map 73L, Group G, Parcel 02600.

Section 2. BE IT FURTHER ORDAINED that this Ordinance shall become effective immediately upon its passage, after second and final reading, **THE PUBLIC WELFARE REQUIRING IT.**

Mayor Brundige explained you have heard the reading of Ordinance O2008-02. I will now entertain a motion.

Alderman Harrison made the motion to approve on the first reading Ordinance O2008-02: An ordinance to amend the Municipal Zoning Ordinance and Map for Martin, Tennessee, by rezoning a tract of land located at 235 University Street from R-2 (Medium Density Residential) to R-4 (Residential-Professional), seconded by Alderman Edwards.

Mayor Brundige stated in your packets you have letters from Mr. Marvin Flatt and Dr. Elaine Harriss opposing the zoning change, a signed petition from area residents opposing the zoning change, and a handout of the proposed development by Leslie and Tim Moore. Copies are attached to the minutes.

Alderman Tuck asked will there be a sign in the front yard or on the building?

Mr. Moore stated our intention is to have a sign designed that is allowed under the R-4 zoning requirements. I will get with the building inspector but we would like to go with a low sign in the front yard with soft lighting on a timer that will turn off around ten pm and one on the structure if possible.

Mayor asked Mr. Stout, Building Inspector, what signs were permissible in an R-4?

Mr. Stout answered R-4 Sign Requirements in the Zoning Ordinance are a maximum of 32 square feet, maximum height of ten feet, and the maximum horizontal or vertical dimension not exceed eight feet. Also allowed is one structural sign limited to twenty square feet to the primary structure with no projection greater than six inches and with placement to the side of the building. Signs maybe illuminated by direct and steady means only and are not permitted on the roof.

Mayor Brundige asked are there any other questions from the board?

Alderman Harrison called for the question.

Mayor Brundige introduced and presented for consideration the second and final reading and public hearing of Ordinance O2008-04: An ordinance amending section 2-209 of the beer ordinance of the City of Martin to create a class of beer permits which can be granted to caterers.

Public Hearing

Mayor Brundige open the meeting for the public hearing of Ordinance O2008-04 by asking if there was anyone present wishing to speak for or against the ordinance.

Alderman Harrison stated I think we need to adopt this ordinance, as it will give us more control over a situation such as this.

No one else spoke.

Mayor Brundige closed the public hearing and asked Recorder Mathis to read the ordinance.

Recorder Mathis read Ordinance O2008-04 and explained a copy of the ordinance has been provided for the Board, media and any interested persons. A copy of the ordinance follows:

ORDINANCE 02008-04

AN ORDINANCE AMENDING SECTION 2-209 OF THE BEER ORDINANCE OF THE CITY OF MARTIN TO CREATE A CLASS OF BEER PERMITS WHICH CAN BE GRANTED TO CATERERS

WHEREAS, the City of Martin Board of Mayor and Aldermen is aware that numerous parties and events take place in Martin at which alcoholic beverages, including beer, are sold and served to guests. The City of Martin Board of Mayor and Aldermen does not wish to restrict such activities, but believes there is a need for some regulation concerning the selling and serving of beer at such events; and

WHEREAS, the current Beer Ordinance of the City of Martin contains no provision for granting beer permits to caterers providing food and drink service for such events.

NOW, THEREFORE BE IT ORDAINED BY THE BOARD OF MAYOR AND ALDERMEN OF THE CITY OF MARTIN AS FOLLOWS:

Section 1. The following provision is to be inserted into the City of Martin Beer Ordinance as new Section 2-209(4):

Section 2-209(4). Class D-On Premises Permit

To qualify for a Class D-On Premises Permit, the applicant must be a caterer meeting the following definition: "Caterer" means a business engaged in offering food and beverage service for a fee at various locations, and which:

- A. Operates a permanent catering hall on an exclusive basis;
- B. Has a complete and adequate commercial kitchen facility; and
- C. Is licensed as a caterer by the Tennessee Department of Health.

The restriction contained in Section 2-206(C)(2), which limits a beer permit to one location, shall not apply to Class D-On Premise Permits. The applicant shall give notice to the Board of locations at which catering services shall be rendered under the permit. Such locations shall be considered to be within the licensed premises for purposes of this Ordinance.

Section 2. This Ordinance shall take effect immediately upon its passage on the second and final reading, **THE PUBLIC WELFARE REQUIRING IT**.

Mayor Brundige explained the board accepted Director of Parks and Recreation Dennis Suiter's retirement request for June 30, 2008 at the May Board Meeting. Now, we have a request from Director Suiter to extend his retirement to August 31, 2008 to allow him to complete the duties of the Cal Ripken World Series. Do I have motion to allow this request?

No motion. Request dies from lack of a motion.

Mayor Brundige stated I should have informed you all of this before I asked for a motion. I will inform you all now and open the floor up for a motion again. I talked to the Parks and Recreation staff Friday and each one indicated that they could work with Director Suiter and pledged their full cooperation during this time period. I forgot to mention this and I apologize. Now I will open up the meeting for a motion on the request from Director Suiter to extend his retirement date till August 31st.

No motion. Request dies from lack of a motion.

Mayor Brundige introduced a proposal from Director Suiter to work twenty hours per week till the completion of the Cal Ripken World Series under TCRS rules, which will allow him to work the twenty hours a week for sixty days. The time period would be from July 1, 2008 through August 29th or 30th. I will ask for a motion on this request.

No motion. Request dies from lack of a motion.

Director Suiter spoke, "First of all in regard to my retirement date I was asked by an Alderman last week as to why I was retiring June 30th. As I have stated several times before, my intention was to retire at the end of this calendar year or the very latest June 30, 2009, which would have been in line with Judy's retirement plans. I certainly never thought I would find myself in a retirement dilemma which would have jeopardized my capacity to finish the job with the Cal Ripken World Series. It is extremely important to me that the public knows and is fully aware that my retirement decision rested solely with the recent change by this board on the policy regarding health coverage insurance. Since I meet the early retirement guidelines, failure to retire by June 30th would result in the loss of all health coverage. For all practical purposes, I had no real decision to make. The top three highlights of my career with the City of Martin will be Santa's Village, the outstanding Martin Recreational Complex, and of course the awarding of the Cal Ripken Majors Sixty World Series. I shall finish out my time through the end of this month and wish the very best for whoever takes the reigns from here. To share just a little information for you and this certainly is not 100% accurate, but I am proudly ready to turn over some ninety notebooks, twenty-four expandable binders, thirtyone media guides, twenty-six additional files, total pieces of paper that have been produced to this point is over twenty-five thousand. Of course, the bulk of this that will be turned over to whomever is in a good condition to take it and go from there. Last month during a high school district softball game a gentleman came up to me and wanted to know if I was the Martin Parks and Recreation Director. He proceeded to tell me about his son who had competed in our Regional Punt, Pass, and Kick competitions, and went on to tell me the fact that he remembered the consideration that I gave

by setting up the competition on the end of the field with the wind to the participant's back so as to give each and every contestant the very best edge they could in order to score high enough to move to the next level. Interestingly, shortly after that during Westview Regional Seven play-off game against Haywood County a gentleman approached me very similarly, the same way. He wanted me know that he remembered me helping him during a tournament three years ago when his daughter was knocked unconscious during a play. He reminded me of the fact that I went to the hospital with them and offered to do anything I could. We talked for several minutes watching his daughter play shortstop. Boy, it is the little things like this that mean the world to me. To those who are openminded and appreciate the many improvements and great strides made in the area of Parks and Recreation and for our citizens I want to thank you for your support and confidence you have placed in me to serve this city. I simply could have never been able to do my job without the support of great folks like are here tonight and I want to thank every one of you that are here on my behalf tonight. I really appreciate it. In addition, to the ones that are here tonight there have been countless others who have approached me and Judy. They have approached me in the grocery store, church, and just about anywhere we have gone we have been addressed by folks indicating their support and I guess the most meaningful thing to me on a number of occasions that they were praying for us. My family has been and continues to be my strength in all that I have faced. And I love them beyond words. My family,just a minute..., my family, friendships, love and faith in God allows me and my family to meet any challenge and to overcome any obstacle to assure that in the end good will prevail. I can and will leave this position with the utmost of pride for the countless accomplishments during my twenty-four year tenure. I did not do this alone. Nor have I ever insinuated such. I have given credit where credit was due. It has been a team effort with staff, individuals, families, businesses, civic clubs, and others who were willing to step forward to be a part of improving the quality of life for our city and our community. I will not allow anything or anybody to dampen my sprits. I will retire relishing the friendships of those who have been willing to place pride above ego, appreciation above jealousy, and foresight above personal agendas."

Mayor Brundige thanked Director Suiter.
