DEPARTMENT HEAD REPORTS

PUBLIC WORKS

DIRECTOR BILLY WAGSTER

Director Wagster asked if there were any questions concerning his monthly report, which was included in packets. A copy is attached to the minutes.

Director Wagster also explained the city sewer rehab project is almost completed. The bids came in under budget. Therefore, we have some money left from the initial contract. We plan to add an addendum to the contract which will complete another 1,100 feet of line.

Public Works has ordered 100 Tons of salt for winter weather usage. Half of it is on hand with the second half to be delivered at a later date.

Alderman Hankins stated several people in Ward III have called me to compliment Public Works on a job well done with the leaf pickup.

Director Wagster stated thank you, leaf pickup is almost complete as we have been over the city twice. People typically do a lot of leafing during the Christmas and New Year's break so we will make a third trip over the city and hopefully it will be the last one. We typically put the leaf machine up by the second week of January.

POLICE DEPARTMENT
