INTRODUCTION AND PRESENTATION FOR THE FIRST READING OF ORDINANCE O2009-05: AN ORDINANCE TO AMEND THE MUNICIPAL ZONING ORDINANCE AND MAP FOR MARTIN, TENNESSEE, BY REZONING FOUR TRACTS OF LAND LOCATED ON ELM STREET SOUTH OF THE INTERSECTION WITH PEACH STREET FROM R-1 (LOW DENSITY RESIDENTIAL) TO B-2 (INTERMEDIATE BUSINESS)

Mayor Brundige introduced and presented for consideration the first reading of Ordinance O2009-05: An ordinance to amend the Municipal Zoning Ordinance and map for Martin, Tennessee, by rezoning four tracts of land located on Elm Street south of the intersection with Peach Street from R-1 (Low Density Residential) to B-2 (Intermediate Business).

Recorder Mathis read Ordinance O2009-05. A copy of the ordinance has been provided for the members of the press and any interested citizens. A copy follows:

#### ORDINANCE O2009-05

AN ORDINANCE TO AMEND THE MUNICIPAL ZONING ORDINANCE AND MAP FOR MARTIN, TENNESSEE, BY REZONING FOUR TRACTS OF LAND LOCATED ON ELM STREET SOUTH OF ITS INTERSECTION WITH PEACH STREET FROM R-1 (LOW DENSITY RESIDENTIAL) TO B-2 (INTERMEDIATE BUSINESS).

**WHEREAS**, pursuant to *Tennessee Code Annotated*, Section 13-7-201 through 13-7-211, the City of Martin has adopted a Municipal Zoning Ordinance; and

**WHEREAS,** in accordance with *Tennessee Code Annotated* Sections 13-7-203 and 13-7-204, the Martin Municipal-Regional Planning Commission has recommended the following amendment to the Municipal Zoning Ordinance and Municipal Zoning Map relative to the rezoning of territory; and

WHEREAS, the Martin Mayor and Board of Aldermen has deemed such a rezoning of this territory from R-1 (Low Density Residential) to B-2 (Intermediate Business) to be necessary for the welfare of the residents and property owners thereof this City as a whole; and

**WHEREAS**, the Martin Board of Mayor and Aldermen has held a public hearing pursuant to *Tennessee Code Annotated* Section 13-7-203 for the purpose of receiving public comment.

### NOW, THEREFORE, BE IT ORDAINED BY THE MARTIN MAYOR AND BOARD OF ALDERMEN:

**Section 1.** That the Municipal Zoning Map and Zoning Ordinance for Martin, Tennessee be amended by rezoning from R-1 (Low Density Residential) to B-2 (Intermediate Business) the following four tracts of land located on Elm Street south of its intersection with Peach Street and further described as:

Weakley County Tax Map 78, Parcel 02800 and Weakley County Tax Map 79, Parcels 03100, 03101, and 03102.

**Section 2. BE IT FURTHER ORDAINED** that this Ordinance shall become effective immediately upon its passage, after second and final reading, **THE PUBLIC WELFARE REQUIRING IT.**

Mayor Brundige introduced and presented for consideration Resolution R2009-17: A resolution to prohibit handguns in municipal parks, historic parks, nature trails, campgrounds, forest, greenways, waterways, or other similar public places.

Recorder Mathis read Resolution R2009-17. A copy of the resolution has been provided for the members of the press and any interested citizens. A copy follows:

#### **RESOLUTION R2009-17**

# A RESOLUTION TO PROHIBIT HANDGUNS IN PUBLIC MUNICIPAL PARKS, NATURAL AREAS, HISTORIC PARKS, NATURE TRAILS, CAMPGROUNDS, FORESTS, GREENWAYS, WATERWAYS, OR OTHER SIMILAR PUBLIC PLACES

- **WHEREAS**, prior to September 1, 2009, *Tennessee Code Annotated* § 39-17-1311, essentially made carrying weapons in municipally owned parks, playgrounds, civic centers, or other building facilities a Class A misdemeanor; and
- WHEREAS, Public Chapter No. 428 (House Bill 716 and Senate Bill 976) of the 106th General Assembly, as adopted, removed the above mentioned prohibitions in public parks for persons authorized to carry handguns pursuant to *Tennessee Code Annotated* § 39-17-1351; and
- **WHEREAS**, Public Chapter No. 428 of the 106th General Assembly permits municipal and county governments to prohibit, by resolution, the carrying of handguns while within a public park that is owned or operated by a county, a municipality, or their instrumentalities; and

**WHEREAS**, the Board of Mayor and Aldermen of the City of Martin, Tennessee desires to continue prohibiting the carrying of handguns in municipal parks; now, therefore:

### BE IT RESOLVED BY THE BOARD OF MAYOR AND ALDERMEN OF THE CITY OF MARTIN THAT:

SECTION 1. Any person authorized<sup>1</sup> to carry a handgun under *Tennessee Code Annotated* § 39-17-1351, is prohibited from possessing any handgun while within a public park, natural area, historic park, nature trail, campground, forest, greenway, waterway, or other similar public place that is owned or operated by the City of Martin or any of its instrumentalities. This prohibition of handguns within any municipal park applies to the entire park, notwithstanding the provisions of T.C.A. § 39-17-1311(b)(1)(I).<sup>2</sup> However, this resolution does not prohibit lawful possession of any handgun in accordance with T.C.A. § 39-17-1311(b)(1)(A)-(H).<sup>3</sup>

**SECTION 2.** The City of Martin shall display signs in prominent locations about the public recreational property, at least six inches (6") high and fourteen inches (14") wide, stating:

MISDEMEANOR – STATE LAW PRESCRIBES A MAXIMUM PENALTY OF ELEVEN (11) MONTHS AND TWENTY-NINE (29) DAYS AND A FINE NOT TO EXCEED TWO THOUSAND FIVE HUNDRED DOLLARS (\$2,500) FOR CARRYING WEAPONS ON OR IN PUBLIC RECREATIONAL PROPERTY.

**SECTION 3.** If a part of this Resolution is invalid, all valid parts that are severable from the invalid part remain in effect. If a part of this Resolution is invalid in one or more of its applications, the part remains in effect in all valid applications that are severable from the invalid applications.

**SECTION 4**. This resolution takes effect from and after its passage, the welfare of the City of Martin requiring it.

<sup>&</sup>lt;sup>1</sup> Any person who is not authorized to carry a handgun under state law and who possesses a handgun in a park or other public area with the intent to go armed would be in possible violation of T.C.A. § 39-17-1307, which is a Class E felony.

<sup>&</sup>lt;sup>2</sup> The state statute requires the prohibition of handguns to apply to the entire park. The statute does not mention the other recreational areas in this proviso.

<sup>&</sup>lt;sup>3</sup> The state statute allows for the lawful possession of handguns in numerous circumstances, including but not limited to military personnel, civil officers, reserve officer training corps pupils and law enforcement officers in discharge of their official duties; private police employed by the municipality; persons who are either hunting on municipal land designated as open to hunting, traversing municipal property to gain access to hunting lands, conducting or attending a gun show, picking up or delivering passengers who do not use the weapon in any way, or a person permitted to sport or target shoot; or a security guard who meets the requirements of T.C.A. Title 62, Chapter 35.

#### **GUNS IN PARKS**

By Kleinheider, posted on July 13, 2009 at 12:48 pm From the Williamson Herald:

Minutes: City of Martin Board of Mayor and Aldermen, July 13, 2009

Williamson County's Board of Commissioners unanimously approved a resolution to prohibit handguns in county parks, or other similar public places after an amendment by Commissioner Jason Para to sunset the law on May 31, 2010.

Para's amendment did not pass unanimously, with six commissioners voting against it. While the provision to prohibit guns in parks would "sunset" or expire on May 31, 2010, Para's amendment also carried a clause to allow the prohibition to be lifted when and if the Williamson County Board of Education received clarification to the law recently passed by Tennessee General Assembly which allowed the school board to agree that it could use county parks if guns were present.

School officials have said existing federal laws would prohibit them from using county parks for athletic and other school-related events and to replace those facilities was reported by County parks Director Doug Hood to carry a price tag of approximately \$35 million.

Mayor Brundige stated I am sure these folks have researched this. I have not. But, I do know there is a federal law that prohibits school events from being held where guns are permitted. You have heard the reading of Resolution R2009-17. Do I have a motion to approve?

Alderman Tuck made the motion to approve Resolution R2009-17: A resolution to prohibit handguns in municipal parks, historic parks, nature trails, campgrounds, forest, greenways, waterways, or other similar public places, seconded by Alderman Harrison.

Alderman Hankins spoke – I have talked to several people that have gone through the hoops to get a permit to carry guns and it is a big deal. There are approximately 460 guns permitted to individuals in Weakley County. I don't think we are trying to say guns are bad but I don't think we need to have guns in our parks, baseball fields, or whatever. I am one of the biggest hunters in this county. I hunt all the time. That is what I wanted to say.

## A RESOLUTION MAKING APPROPRIATIONS TO CERTAIN NON-PROFIT CHARITABLE ORGANIZATIONS, FOR THE FISCAL YEAR BEGINNING JULY 1, 2009 AND ENDING JUNE 30, 2010

**WHEREAS**, the Board of Mayor and Aldermen for the City of Martin, Tennessee, has determined that it would benefit the general welfare of the residents of Martin if appropriations were made to certain non-profit charitable organizations: and

**WHEREAS**, Tennessee Code Annotated 6-54-111 allows the legislative body of a municipality to appropriate funds under certain conditions for non-profit charitable organizations.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Mayor and Aldermen for the City of Martin, that

- **SECTION 1**. a. One thousand dollars (\$1,000.00) be appropriated to the Kiwanis Club for the annual Christmas Parade.
  - b. Five thousand dollars (\$5,000.00) be appropriated to Community Developmental Services, Inc.
  - c. Twenty-one thousand dollars seven hundred dollars (\$21,700.00) be appropriated for the community activity Soybean Festival.
  - d. Two thousand seven hundred fifty dollars (\$2,750.00) be appropriated to the Miss Tennessee Soybean Scholarship.
- **SECTION 2.** In accordance with T.C.A. 6-65-111, this appropriation is made on the condition that the non-profit charitable organization for which these funds are appropriated shall file with the City Recorder's office a copy of an annual report of its business and transactions, which includes, but is not limited to, a copy of an annual audit, its programs which serve the residents of the City of Martin and the proposed use of the municipal assistance. The City Recorder shall consult with appropriate officials of the organization and auditors for the City to determine the extent of the information, which shall satisfy the requirement of this section.

**SECTION 3.** It is the expressed intent of the Board of Mayor and Aldermen of the City of Martin in making this appropriation to be fully in compliance with T.C.A. 6-54-111 and Chapter 0380-3-7 of the Rules of the Comptroller of the Treasury, State of Tennessee.

**SECTION 4.** This resolution shall take effect upon its passage, **THE PUBLIC WELFARE REQUIRING IT.**

# INTRODUCTION AND PRESENTATION OF RESOLUTION R2009-21: A RESOLUTION TO ESTABLISH WATER AND SEWER RATES FOR CUSTOMERS OF THE MARTIN MUNICIPAL WATER AND SEWER SYSTEMS

Mayor Brundige introduced and presented for consideration Resolution R2009-21: A resolution to establish water and sewer rates for customers of the Martin Municipal Water And Sewer Systems.

Recorder Mathis read Resolution R2009-21. A copy of the resolution has been provided for members of the press and any interested citizens. A copy follows

#### **RESOLUTION R2009-21**

#### A RESOLUTION TO ESTABLISH WATER AND SEWER RATES FOR CUSTOMERS OF THE MARTIN MUNICIPAL WATER AND SEWER SYSTEMS

**WHEREAS,** Section 18-128 of the Martin City Code provides that the rate schedule for water and sewer services are to be determined and set by the City from time to time; and

**WHEREAS**, the City of Martin, following a study of its financial needs and the existing user fee structure, has determined the need for an adjustment to the City's water and sewer rates.

**NOW, THEREFORE,** in consideration of these facts be it resolved by the Board of Mayor and Aldermen of the City of Martin, Tennessee, as follows:

Section 1. <u>Water Rate Schedule.</u> All customers of the Martin Municipal Water System shall pay for such water service according to the following schedule:

Section 2. <u>Sewer Rate Schedule.</u> All customers of the Martin Municipal Sewer System shall pay for such sewer services according to the following schedule:

Section 3. <u>Sales Taxes on Municipal Utilities.</u> The water rate schedule specified in Section 1 of this resolution and the sewer rate schedule specified in Section 2 of this resolution are exclusive of all state and local sales taxes.

### Section 4. <u>Effective Date.</u> This resolution shall take effect upon its passage, **THE PUBLIC WELFARE REQUIRING IT.**

Section 5. <u>Severability.</u> Should any section, paragraph, sentence, clause, or phrase of this resolution or its application to any person or circumstance be declared unconstitutional or otherwise invalid for any reason, or should any portion of this resolution be pre-empted by State or Federal law or regulation, such decision or legislation shall not affect the validity of the remaining portions of this resolution or its application to other persons or circumstances.

Section 6. <u>Repealer.</u> All resolutions and parts of resolutions, which are inconsistent with the provisions of this resolution, are hereby repealed to the extent of such inconsistency.
