## AN ORDINANCE TO ADOPT THE INTERNATIONAL BUILDING CODE, 2006 EDITION; AND THE INTERNATIONAL RESIDENTIAL CODE, 2006 EDITION BY REFERENCE

- WHEREAS, pursuant to authority granted by *Tennessee Code Annotated 6-54-501 through 6-52-506* and for the purpose of establishing the minimum requirements to safeguard the public health, safety and general welfare through structural strength, means of egress facilities, stability, sanitation, adequate light and ventilation, energy conservation, and safety to life and property from fire and other hazards attributed to the built environment; and
- WHEREAS, the Martin Mayor and Board of Aldermen has deemed the adoption of the International Building Code, 2006 Edition and the International Residential Code, 2006 Edition by reference to be necessary for the welfare of the residents and property owners thereof this City as a whole; and
- **WHEREAS**, the Martin Board of Mayor and Aldermen has held a public hearing for the purpose of receiving public comment.

## NOW, THEREFORE, BE IT ORDAINED BY THE MARTIN MAYOR AND BOARD OF ALDERMEN:

- Section 1. That the International Building Code, 2006 Edition and the International Residential Code, 2006 Edition is hereby adopted by reference and are hereinafter referred to as the international building codes.
- Section 2. Modification. Whenever in the international building codes reference is made to the duties of a certain official named therein, that designated official of the City of Martin who has duties corresponding to those of the named official in said codes shall be deemed to be the responsible official insofar as enforcing the provision of the international building codes are concerned.

- Section 3. Available in recorder's office. Pursuant to the requirements of *Tennessee Code Annotated 6-54-502* one (1) copy of each of the international building codes have been placed on file in the recorder's office and shall be kept there for the use and inspection of the public.
- Section 4. Violations and penalty. It shall be unlawful for any person to violate or fail to comply with any provision of the international building codes as herein adopted by reference and modified. The violation of any section of this chapter shall be punishable by a penalty of up to fifty (50) dollars. Each day a violation is allowed to continue shall constitute a separate offense.
- Section 5. Amendments to the Codes.
  - (a) As an alternative to Chapter 11 of the International Residential Code, 2006 Edition, the International Energy Conservation Code, 2006 Edition may be utilized.
  - (b) International Residential Code, 2006 Edition, Section 313.2.1, Exception 1. is amended to read "Interconnection and hard-wiring of smoke alarms in existing areas shall not be required where the alterations or repairs do not result in the removal of interior walls or ceiling finishes exposing the structure."
- Section 6. BE IT FURTHER ORDAINED that this Ordinance shall become effective immediately upon its passage, after second and final reading, THE PUBLIC WELFARE REQUIRING IT.
