INTRODUCTION, PRESENTATION, SECOND AND FINAL READING, AND PUBLIC HEARING OF ORDINANCE O2010-02: AN ORDINANCE TO AMEND THE MUNICIPAL ZONING ORDINANCE AND MAP FOR MARTIN, TENNESSEE, BY REZONING A TRACT OF LAND LOCATED OFF TYLER AUSTIN ROAD FROM R-1 (LOW DENSITY RESIDENTIAL) TO R1-A (HIGH DENSITY SINGLE FAMILY RESIDENTIAL)

Mayor Brundige introduced and presented for consideration the second and final reading and public hearing of Ordinance O2010-02: An ordinance to amend the Municipal Zoning Ordinance and Map for Martin, Tennessee, by rezoning a tract of land located off Tyler Austin Road from R-1 (Low Density Residential) to R1-A (High Density Single Family Residential). This is a recommendation from the City of Martin Municipal Regional Planning Commission.

Recorder Mathis read the ordinance. A copy of the ordinance has been made available to the media and any interested persons. A copy follows:

#### **ORDINANCE 02010-02**

AN ORDINANCE TO AMEND THE MUNICIPAL ZONING ORDINANCE AND MAP FOR MARTIN, TENNESSEE, BY REZONING A TRACT OF LAND LOCATED OFF TYLER AUSTIN ROAD FRO R-1 (LOW DENSITY RESIDENTIAL) TO R-1A (HIGH DENSITY SINGLE FAMILY RESIDENTIAL)

- **WHEREAS,** pursuant to *Tennessee Code Annotated*, Section 13-7-201 through 13-7-211, the City of Martin has adopted a Municipal Zoning Ordinance; and
- WHEREAS, in accordance with *Tennessee Code Annotated* Sections 13-7-203 and 13-7-204, the Martin Municipal-Regional Planning Commission has recommended the following amendment to the municipal Zoning Ordinance and Municipal Zoning Map relative to the rezoning of territory; and
- WHEREAS, the Martin Mayor and Board of Aldermen has deemed such a rezoning of this territory from R-1 (Low Density Residential) to R-1A (High Density Single Family Residential) to be necessary for the welfare of the residents and property owners thereof this City as a whole; and
- **WHEREAS**, the Martin Board of Mayor and Aldermen has held a public hearing pursuant to *Tennessee Code Annotated* Section 13-7-203 for the purpose of receiving public comment.

### NOW, THEREFORE, BE IT ORDAINED BY THE MARTIN MAYOR AND BOARD OF ALDERMEN:

Section 1. That the Municipal Zoning Map and Zoning Ordinance for Martin, Tennessee be amended by rezoning from R-1 (Low Density Residential) to R-1A (High Density Single Family Residential) the following tracts of land located off Tyler Austin Road and further described as:

Weakley County Tax Map 78B, Group B, Parcels 01700 thru 02300 and 02700 thru 04100.

**Section 2. BE IT FURTHER ORDAINED** that this Ordinance shall become effective immediately upon its passage, after second and final reading, **THE PUBLIC WELFARE REQUIRING IT.**

Mayor Brundige explained the contract is to put out for bids and the proposal is only an estimated amount. We hope the bids will be lower than our estimate. Do I have a motion?

Mayor Brundige explained this is an estimated cost and we will have to bid this out to know exactly how much the cost will be. We estimated this at \$80.00 per ton hoping the bid will be less.

Alderman Edwards stated the money we have set aside for paving is State Street Aid funds and must be used for streets.

Alderman Harrison stated I have one more question. Mayor on this list that we are going to work, who makes out this list?

Mayor Brundige stated the department head and I rode over the streets making our decision from observation. We presented the list to the Public Works Committee and they approved it as a recommendation to the City Board. There are probably several more streets that need attention when money is available.

Alderman Harrison stated yes there are and I would ask you all to consider Cooper Street from K Street to Olney Street. That section is in pretty bad shape.

Mayor Brundige stated – Bill, if the bids are lower, the Board can add streets to the contract.

Alderman Harrison called for question.
